GRIFFITH

Church records at Hempstead begin in 1725. Church records in Huntington begin in 1723. The first GRIFFITH record is that of William baptized in Huntington, New York, by Rev. Prime, June 6, 1736.

The marshals who took censuses in the early days, the population and the clerks were often not well educated, with the result names were spelled in various ways. No decision as to the identity of a person on the early censuses and records can safely be based solely on the spelling. The script was often very difficult to read.

Origin and meaning of the family name -

GRIFFITH: Bapt. (Welsh)

A variant of GRIFFIN.

GRIFFIN means: the son of 'Griffin' or "Griffith", the name of many Welsh princes.

Variations are: Griffiths, Griffeth.

The name GRIFFITH was often recorded as GRIFFIN, GRIFFITH, GRIFFITHS, GRIFFETH, GRIFFIS, GRIFFEN, GRIFFING, ETC. In writing this history, to avoid confusion, the name GRIFFITH only was used, except to clarify how the name GRIFFIS got started.

GRIFFITH - THEIR WELSH HISTORY 1485 - 1602

- 1. RICHARD GRIFFITH, of Walton, Pembroke, South Wales, married Elsbeth, sister of Wm. Mor Esq. Richard was a soldier of Henry VII, and was present at Bosworth Field 1485.
- 2. GRIFFITH GRIFFITH (Richard¹) married Jowan, daughter of Seimont David Esq. of Koksol, Gent. They had a son, John Griffith.
- JOHN GRIFFITH (Griffith², Richard¹) 3. married Ann, daughter of Edward Lanfort They had two sons, Edward born 1602, John and two daughters.
- EDWARD GRIFFITH, born 1602 (John³, Griffith², Richard¹) 4. married Mary 1653. Edward left London for Virginia October 24, 1635 at age 33. He had been in the King's service and was convicted, as the record states, while in line of duty, of justifiable manslaughter, and at once granted pardon by the King January 7, 1625. He was afterwards a trusted servant and financial agent for Lady Wake 1633.

THE GRIFFITH COAT OF ARMS

Coats of Arms were often used for purposes of identification and recognition on the field of battle as well as in civil life.

In 1528 Henry V111, King of England, appointed a commission to visit each country of his kingdom, and summon his subjects of rank to appear for examination as to their heraldic rights. This procedure was repeated at irregular intervals and a record, known as "visitations", kept.


The ancient GRIFFITH Coat of Arms which is correctly described below has been in the GRIFFITH family for many centuries. It was, in its original form, used by GRIFFITH AP CYNAN, KING OF NORTH WALES, A.D. 1079.

As a matter of personal taste, which is permissable, some members of the family vary the shape of the shield and of other features of the Arms. The mantle and helmet which are sometimes seen with Coats of Arms are merely ornamental and may be correctly included or omitted.

Besides its family significance and inspiration this Coat of Arms painted in full brilliant colors makes an excellent mural ornament.

EDWARD GRIFFITH who was born in 1602 in Wales left London, England for Virginia on October 24, 1635, age 33, on the "ABRAHAM".

Two boats left London, England on October 24, 1635; the "Abraham" and the "Constance" with 132 men and 4 women bound for Virginia, all in the service of Capt. Claybourne and his partners. Edward was on the "Abraham", his brother, John, born 1609, was on the "Constance". There is no record of John remaining in America.

EDWARD was in the service of Capt. Wm. Claybourne in the war between him and Lord Baltimore in 1638, where Edward was captured by Lord Baltimore but was able to escape to Maryland and came to New Amsterdam in 1640 where he proved himself to have been a prisoner and was released and set at liberty. For a time he lived in Gravensend, but finally to Flushing, Long Island, New York, where he ever afterwards lived and died leaving issues there.

From History of Long Island by Ross, Vol. 1, EDWARD GRIFFITH bought fifty acres of the lands of Midout "on the west side of the road near the Flatbush", Feb. 28, 1653, from Gerritt Bycken, and, sold same July 27, 1653 to Bartel Loot and Peter Loot.

Lands in the vicinity of that of Samuel, remained in the family until recent years.

FOOTNOTE: A RICHARD GRIFFITH emigrated from Wales and was one of the first settlers of Long Island. He lived in Flushing and had several children; but, it is uncertain how many. The family of JOHN GRIFFEN at Purchase, N.Y. and John and Joseph at Amawalk, New York, were descendants of his, but this is not of our line and this Richard was not a son of Edward and Mary.

Research proves that the RICHARD who married Susanna Haight was the son of Edward and Mary.

5. RICHARD⁵ GRIFFTH (Edward⁴, John³ b. abt. 1654, Griffith², Richard⁵)

married Susanna Haight. They had fourteen (14) children:

Samuel left several children. He went East (Huntington is east of Flushing).

James went to Oxford and was a military man. He married in Boston, but had no children.

Jonathan, Edward, and Obediah settled in Westchester Co.

Jonathan was a military character, and had no children except an adopted son.

Several of the children of Richard and Susanna settled in Nine Partimers, Dutchess County, New York.

Descendants of Isaiah, Obediah and Gilbert immigrated to Canada.

LIST OF FREEHOLDERS IN SUFFOLK COUNTY, 27 February 1737: SAMUEL GRIFFING (it is the belief that this is the above SAMUEL GRIFFITH).

New York Genealogical and Biographical Records states SAMUEL went east. (This could be east from Flushing to Huntington). SAMUEL left several children. Family tradition -

Albert Buffett Griffith told his daughter-in-law, Lillian Evelyn Soper Griffith, that his great, great grandfather's name was SAMUEL.

In the tumultuous days preceding and during the Revolution, many records and many buildings were destroyed. At best the records are sketchy and inconsistent, and, obviously the spelling by clerks laboriously writing by hand was casual and irregular; for instance, in one book we find the name spelled GRIFFIS on one page and then spelled GRIFFITHS on another page.

CHURCH RECORDS in Huntington begin in 1723. The first GRIFFITH (Griffis) record is that of WILLIAM baptized in Huntington, New York, by Rev. Prime, Jan. 6, 1736.

For William Griffis, Jr. (Reverend William Griffis), 1797-1878 (son of William, b. 1763) and his descendants see records compiled by Mary Martha Ryan Jones and Capitola Griffis Welch 1969, which record states that William Griffis told his son that his ancestors came from Wales and they spelled the name GRIFFITH OR GRIFFITHS he could never give any reason why they changed it to GRIFFIS.

GRIFFITH IN HUNTINGTON, LONG ISLAND, NEW YORK

GRIFFITH RECORDED AS GRIFFIS due to a lisp.

According to the family legend, as told by Albert Buffett Griffith to his daughter-in-law, Lillian Soper Griffith, WILLIAM GRIFFITH had difficulty pronouncing "th", and in a name or word the "th" sounded like an "s". As this speech impediment was an embarrassment to him, he allowed the clerk to record his name as GRIFFIS rather than confessing the spelling was GRIFFITH which would have called the clerk's attention to the impediment.

The descendants of his son WILLIAM continue to spell the surname GRIFFIS,

whereas the descendants of his son JAMES spell this surname GRIFFITH.

JAMES remained in Huntington, New York, where his descendants are now living.

WILLIAM born Feb. 7, 1763, died in 1847 at the home of his son, the Reverend William Griffis, in Dawn Township on the River Sydenham in Upper Canada, near Chatham. When he was about thirty years of age he moved from near Albany, New York, to Fredericksburg, "in the incorporate counties of Lenox and Addington". His township was Adolphustown, Midland District, and Province of Upper Canada. Here he resided the remainder of his life.

WILLIAM GRIFFITH AND ABIAH GATES GRIFFITH named two of their children WILLIAM, as follows:

- William Gates, baptized Nov. 7th, 1756, served in the American Revolution, settled in Oneida County, New York.
- William, born Feb. 7, 1763, served in the American Revolution from Dec. 1, 1775 until the fall of 1780, in periods of from three to five months each, first doing fatigue duty, then garrison duty and scouting. He was engaged in the Battle of Schoharie.

(The above information regarding the two WILLIAMS, William Gates and William, and other detail are of record).

In the early 1880s he was co-owner of a livery stable with many fine carriages and race horses. He often told of hiring a horse and carriage to Tom Thumb and his wife when these little midgets were at the height of their fame. He thought they were a very delightful couple.

After the livery stable business, THE HUNTINGTON MARKET (Choice Meats), on Main Street, Huntington, New York, established in 1888, which business is now the oldest family owned meat market in the Town of Huntington and owned and operated on Main Street, Huntington, New York, at this time by his grandson, Clarence Albert Griffith, Jr.

Among his illustrious customers were the following:

Theodore Roosevelt, the 26th President of the U.S., and his charming wife, when they lived in Oyster Bay, New York, during his presidency and for many years after.

William McAdoo, son-in-law of President Woodrow Wilson, during McAdoo's term of office as Secretary of the Treasury and many years thereafter.

He was an unpretentious, industrious family man who gave good, sound advice and money to those in need and never betrayed a confidence or ever told anyone, not even his own family, of all those he helped along the way, as he lived by his creed of being of service to his fellow man.

He and his wife are buried in the family plot, Huntington Rural Cemetery, Huntington, N.Y.

C. A. GRIFFITH PROMINENT NATIVE

Clarence Albert Griffith of 160 West Neck Road, Huntington, active in business, real estate, banking and community affairs here, passed away Saturday at his home. Mr. Griffith suffered a heart attack earlier in the summer.

Mr. Griffith was the founder and owner of several businesses and real estate properties in Huntington. Since World War 11, however, his real estate properties in Huntington. Since World War 11, his career in banking dominated his business activities and he served the Security National Bank of Long Island, formerly the First National Bank of Huntington, as both a director since 1942 and a vice president. He retired from the bank this Spring.

Until his death, Mr. Griffith was chairman of the Board of Fire Commissioners for the Huntington Fire Department, a position he held for more than 45 years. He was a charter member and past president of the Huntington Rotary Club, a former president of the Huntington Businessmen's Association; a member of the Jephtha Lodge No. 494 F. and A.M.; the Sons of the American Revoluation, and a charter member of American Legion Post No. 360. He also served on the advisory commission for the 1939 New York Worlds Fair.

Mr. Griffith was a director of the Huntington YMCA, as well as the Suffolk County Chapter of the American Society, and the Hotel Huntington Corporation. He belonged to the Huntington Yacht Club.

Born in Huntington in 1894, to Albert and Lillian Soper Griffith, he graduated from Huntington High School in 1913. During World War 1, Mr. Griffith served in the American Expeditionary Forces in France and was discharged with the rank of first sergeant.

In 1920 he married Irma Huxley, daughter of Mr. and Mrs. F. B. Huxley of Ontario, N.Y. After her death in 1952, he married Edna Elizabeth Johanns Walther who survives.

Also surviving are his son, C. Albert of Huntington; a sister, Mildred Peets of Riviera Beach, Fla.; a brother Russell of Huntington; his stepson, Charles R. Walther of New York City and nine grandchildren.

Huntington Fire Department, Jephtha Lodge and American Legion Huntington Post, held services Monday night at the Fasbender-Touey Funeral Home. Religious services were Tuesday afternoon at St. Peter's Lutheran Church where he was a member, with the Rev. John A. Kavasch officiating. Interment took place in St. John's Memorial Cemetery, Cold Spring Harbor.

At Buffalo, New York, in 1818, he joined the United States Army and rendered valuable service.

A copy of his biography, dictated by him to his son David J. Ryan, gives his story in full. He did not reveal his true name to his children until 1874, two years before his death. He declared a reward had been offered for his head after his desertion, and changed his name from "Peter Gee" to "Samuel Ryan" to escape detection. A copy of his biography is in the Mariner's Museum, Newport News, Va., also in the Wisconsin State Historical Museum.
